The New Junior Cycle (JCSA)

The New Junior Cycle (JCSA) is due to be implemented next September with the introduction of English. Much consultation and debate has taken place around this new initiative and is ongoing.

The JCSA will form a newly revised and more interactive learning platform to help students become better learners, to develop skills for learning and for life, to provide a solid foundation for senior cycle, to give students a trial run for the Leaving Cert and to encourage young people to develop a love of learning.

We have an education system in this country which has served our students well at both primary and post – primary level. The Junior Cert has served its purpose to great effect for the last 25 years but moving on and keeping in line with an everyday modernising world, it is time for change. The JCSA will be set out on a more interactive format.

Is this the right way to go?

We believe in this new concept and look forward to working with all partners in education with the interest of the student at the core. We understand there are many concerns around assessment and rightly so. Both Parents and students have a right to feel reassured that this will be administered fairly.

Teachers also have concerns surrounding assessment but we have confidence that with the co-operation of all partners in the education system, this can be resolved. 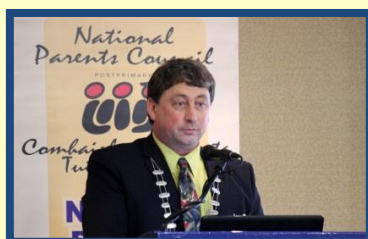
Friday Night started off with a presentation from **Noel Malone, Principal, Coláiste Chiaráin, Co Limerick** on the New Junior Cycle Student Award (JCSA). Coláiste Chiaráin is one of the 48 pilot schools leading the way in pioneering the changes that will occur in the Junior Cycle programme over time. The new junior cycle will feature newly developed subjects and short courses, a focus on literacy, numeracy and key skills, and new approaches of assessment and reporting. Schools will have more freedom to design programmes that meet the learning needs of all students. Among the many subjects introduced in Coláiste Chiaráin, are Experimental Science Investigation, Animal Care and Equine Studies, Television & Radio Broadcasting, Digital Media Creation, Italian Cultural & Communication Studies, Sustainable Energy & Living and Innovative Creative

Entrepreneurship.

Saturday morning began with the Conference Address which was made by **Mr Harold Hislop, Chief Inspector at the Department of Education**. Mr Hislop spoke on the **Chief Inspector's Report 2010-12** which was launched earlier that month by the Minister for Education. The Report gave

account of the quality of education in our primary schools, second-level schools and centres for education. The report acknowledges all the good practice that takes place on an everyday basis in our schools in terms of quality leadership, management, teaching and learning. It also reveals some weaknesses, and it points schools firmly in the path of improvement. The Chief Inspector spoke on how *Parents, students, schools and the quality of learning we can achieve the best education for our children and young people if...the educational system listens to and genuinely respects the voices of parents and all actors in the educational endeavour work together in a shared effort for the good of young people and future citizens.*

20-20 Vision for Education

Mr Ferdia Kelly, General Secretary of the JMB presented the Post Primary Education Forum’s (PPEF) “20-20 Vision for Education” which was launched in 2013. The Post-Primary Education Forum (PPEF) is an umbrella group encompassing representation from parents, students, teachers unions and school management bodies involved in the post-primary education sector. Founded in November 2007, the PPEF seek to address common issues and establish a shared viewpoint on

priorities for the future development of second level education.

Key points of the **20-20 Vision for Education**:

Educational Vision

- National policymakers with focus on quality and quality assurance from a functional perspective
- Partners look to full participation of all the stakeholders to ensure a quality education for students in learning environments where;
- Students well-being is nurtured
- Values of equality and inclusion
- High expectations
- Nourish students’ potential and capabilities
- Tension between the promotion of education as something important in its own right vs. constraints due to economic issues

Parents

- Active participation – not just fund-raisers and tea makers
- Research shows the benefits of being involved in our children’s education
- Parents need to have a clear role in the education policy development at national level – NPCpp

Understanding the Well-Being of Teenagers (How to manage and let go of your 13-18)

Such was his success at last year’s conference workshops that we invited **Dr Fergus Heffernan** to address our entire delegates this year. Dr Heffernan provided an entertaining way of looking at your teenager’s wellbeing in the environment of the family’s wellbeing. He offered very practical advice on how families can thrive during the sometimes difficult teenage times.

- Teenagers and Substance Abuse
- Peer Pressure and Teenagers
- Teenagers and their Mental Health
- The Teenagers role in the family

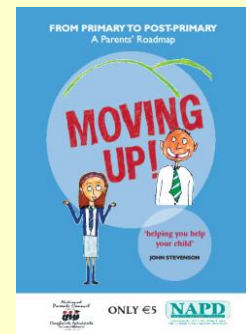
